The Helier Limited Time Offer 2025

Terms and Conditions

- 1. The following offer is only available to prospective residents who:
- a. sign an application for an apartment at The Helier on or before 31 August 2025; and
- b. sign and settle an occupation right agreement for the apartment at The Helier referred to in your application ("ORA") with Oceania Village Company Limited ("Oceania") within 4 months of the application date, including payment of your Occupation Licence Payment in full ("you").

No Periodic Fees for 12 Months

2. Your Village Tariff and Hospitality Charge will be waived for a period of 12 months from the Commencement Date of your ORA. Payment will resume at the usual rates for those charges on expiry of that period.

Moving Package

- 3. Oceania will arrange, at its cost, a moving package valued at up to \$5,000.00 to assist you with your move into your apartment at The Helier.
- 4. If you wish to purchase a more expensive moving package you will be responsible for the cost of that package to the extent that it exceeds the maximum value referred to in clause 3. You are directly responsible for the cost of any additional moving services you choose to purchase.
- 5. Your use of the mover is at your own risk, Oceania is not responsible for any loss or damage caused by the mover.

- 6. On settlement of your ORA Oceania will give you one \$20,000.00 voucher for Soren Liv Furniture.
- 7. On settlement of your ORA Oceania will give you one \$1,000.00 voucher for Art Hangman for professional hanging/installation of your art in your apartment.
- 8. The Soren Liv Furniture and Art Hangman vouchers are subject to any terms and conditions of the issuer. Any disputes arising in respect of these vouchers must be raised directly with the issuer.

Contribution to Legal Costs

- 9. Oceania will pay you a one-off \$2,000.00 contribution to your legal costs associated with entry into your ORA ("Contribution").
- 10. The Contribution will be paid to you by an adjustment of the amount you are required to pay to settle the Occupation Licence Payment in full.

Cancellation
