Terms and Conditions

1. The following offer is only available to prospective residents who:

- a. sign an application for a selected apartment at Remuera Rise Village ("Remuera Rise") and
- b. sign and settle an occupation right agreement ("ORA") for a selected apartment at Remuera Rise with Oceania Village Company Limited ("Oceania") on or before 30 November 2025, including payment of the Occupation Licence Payment in full.

Prospective residents who meet the above criteria are referred to as "you" or "your" below.

No Weekly Village Fees for 12 Months

2. You are not required to pay your Weekly Village Fees, being the amount specified in your application, for a period of 12 months from the Commencement Date of your ORA.

- a. Your Weekly Village Fees specified in your application are required to be paid after the expiry of the 12 months.

Whiteware Package

3. You will get a whiteware package including a washing machine, dryer and fridge/freezer ("Whiteware Package"). The make and model/s of the appliances in the Whiteware Package will be selected by Oceania, who will also be responsible for their purchase and delivery. The Whiteware Package will be installed in the selected apartment prior to you taking occupation of the apartment.

Relocation services

4. Oceania will arrange, at its cost, relocation services from Smart Express (or other provider selected by Oceania) valued at up to \$5,000.00 to assist you with your move into your apartment.

5. If you wish to purchase services that cost more than \$5,000 you will be responsible for the cost of them to the extent that they exceed \$5,000.

You are directly responsible for the cost of any additional services you choose to purchase.

6. Your use of the services is at your own risk, Oceania is not responsible for any loss or damage caused by the relevant service provider.

Tranz Alpine Train Package

You will get a Great Journeys New Zealand "Overnight Escape to West Coast" Tranz Alpine Train Package* for 2, plus return flights from Auckland to Christchurch. The flights and train package will be booked by Oceania and are subject to availability at the time of booking. A minimum travel notice period of 3 months is required for the booking.

Cancellation

7. If your ORA is cancelled in accordance with clause 15 (Your Cooling Off Right) or clause 19 (Your "90 Day Right Place Guarantee") of your ORA:

- a. you will be required to reimburse Oceania for the relocation services that Oceania paid for under clause 3. Oceania will be entitled to deduct this amount from any payment due to you following cancellation of your ORA; and
- b. ownership of the Whiteware Package will transfer to Oceania with effect at cancellation of your ORA and it must not be removed from the apartment.
- c. Oceania will only proceed with booking the Tranz Alpine Train Package after your cooling-off period has expired or after your 90-Day Right Place Guarantee period.
