#### **December 2025 Sales Offer - Terms and Conditions**

- 1. The following offer is only available to new prospective residents\* who:

#### Relocation services

# Cancellation

- 6. If your ORA is cancelled in accordance with clause 15 (Your Cooling Off Right) or clause 19 (Your "90 Day Right Place Guarantee") of your ORA, you will be required to reimburse Oceania for any of the following incentives provided:
  - a. the Weekly Fees that Oceania waived under clause 2;
  - b. the relocation services that Oceania paid for under clause 3; and
  - c. any Contribution (being any payment or benefit expressly described in your ORA or in these Terms and Conditions)
- \*Contribution means any payment made by Oceania to you or on your behalf as part of this promotional offer, other than the waiver of Weekly Fees or relocation services.
  - 7. Oceania will be entitled to deduct any reimbursement for the incentives from any payment due to you following cancellation of your ORA. This reimbursement obligation does not affect your statutory rights under the Retirement Villages Act 2003.
